About this Qualification

The Certificate IV in Veterinary Nursing (ACM40418) qualification is a requirement for those who wish to register and practice as a veterinary nurse in the state of Western Australia. This qualification reflects the role of a veterinary nurse who work as a part of a veterinary team providing expert nursing care for sick or injured animals and supports veterinarians to carry out medical and surgical procedures in the veterinary clinic. Veterinary nurses also play a large role in educating pet owners in how to care for their pets. Training pathways involve a significant practical element to ensure students graduate ready to enter and actively contribute to the workplace.

Course local entry requirements

Entry into this qualification is open to local students who meet the qualification entrance requirements:

- hold a Certificate II in Animal Care or Certificate III in Animal Care Services
 OR
- hold a relevant Certificate III or higher-level qualification in an animal science discipline
 OR
- can demonstrate equivalent skills and knowledge in a relevant animal science discipline to any of the above qualifications.
- have (or can obtain) a national Police Clearance within the last 12 months (certain offences on your police clearance may affect your authorisation with the Veterinary Practice Board)

Course study requirements

Before enrolment, interested students are advised that the following are necessary to enable successful course completion:

	Meet the entrance requirements.
	Willing to commit to 8 hours per week for out-of-class course study activities and can undergo self-directed research and study skills.
	Effective language, communication, and interpersonal skills
	Ability to problem solve and apply critical thinking to assessment tasks and work role requirements.
	A sound working knowledge and application of computer programs e.g. MS Word, Outlook.
	Class attendance (one day a week on campus) and the ability to use an online learning management system (Blackboard) to access training resources and upload documentation.
	<u>Have access to a workplace</u> with a workplace mentor and veterinary supervisor (Veterinarian) that will support your training and skills practice. This condition is vital to enable completion of the assessment requirements for the course.
	Attend industry workplace for a minimum of 2 days or 15 hours a week for the duration of your studies (2 years).
	Intermediate level fitness to manage physical demands like lifting and handling animals.

To Apply

You need to read the general information on pages 2-5 and complete the "ACM40418 Part-time Enrolment Requirements Application" form on pages 6-8. Applications are due 1st November 2024. Offers are sent out 2nd December 2024.

If your application is successful, you will be notified via email advising of the process to complete your enrolment to ensure your place is secured. You will also be advised if you are unsuccessful and the reason: the course is full; your application is incomplete, or the application does not meet the local entry requirements.

General Information

Induction

A mandatory induction session will be held prior to the course commencing.

Study commitment

On campus attendance

Students are required to attend campus one day per week, on a Friday for face-to-face classes for the duration of their studies.

Industry work placement or Industry employment

This course has a mandatory work placement component that all students must complete. To meet the training and assessment requirements of this qualification the part-time study option is open to local students employed or volunteering in a private veterinary clinic for a minimum of two days per week (15 hours) as a student veterinary nurse for the duration of your studies (2 years).

At home study

Students are required to complete pre-reading and preparation prior to attending classes, and research and theory assessment work at home in their own time. The time allocation would be approximately 8 additional hours per week for the duration of the course.

Veterinary Practice Board of WA

To be able to participate in mandatory work placement or employment as a student veterinary nurse you MUST maintain current enrolment in the Certificate IV in Veterinary Nursing qualification at South Metropolitan TAFE. In Western Australia students are required to be authorised by the Veterinary Practice Board of WA and supervised by a registered veterinarian to perform the duties and veterinary services of a student veterinary nurse, as set out in the Regulations 23and Schedule 5 of the Veterinary Surgeons Regulations of 2022.

Assessment deadlines

Completion of practical tasks and submission of theory assessments in a timely fashion is essential. The assessment tasks for the different units will all have various due dates that need to be followed. (i.e. - assessment tasks do not have the entire length of your full course enrolment period to complete, they must be submitted by the due date).

Duration and study modes

The part time course will be delivered on campus one day per week over 2 years or 4 semesters. Key Dates

(Please note: the planned courses will be subject to student enrolment numbers and the number of places available in each course is limited and enrolment will not be possible once the limit has been reached).

Enrolment and course costs

The cost of the full course for Australian or permanent residents, residing in Western Australia is approximately \$2,620 or \$1,290 for concession card holders. (There will be a minor CPI increase) The fees quoted are estimates only and are for all the units in the course for students enrolling on a full-time basis. For the part-time course over four semesters, you will only pay for the units you are enrolling in each semester. Please refer to the 2025 fee schedule

If you are accepted into the course, your information will be passed onto the South Metro TAFE enrolment team, and you would be notified by email to organise payment. You may choose to pay the full semester amount, or the option of setting up a payment plan and paying in instalments is also available.

Recognition of Prior Learning

Following your enrolment, you are encouraged to speak to your Lecturer about the possibility of Recognition of Prior Learning if you believe you have any existing skills and knowledge that may be formally recognised towards the units or qualification you are undertaking. If you have previously completed qualifications or units, speak to your Lecturer regarding the possibility of credit or credit transfer.

Course structure and features

Learning and teaching

The course is delivered in a face-to-face delivery mode with Blackboard used as a learning management system. This contains learning materials, resources, and written assessments. In addition to classroom learning, some of your time on campus will be spent in the South Metro TAFE Student veterinary clinic, a direct public access clinic where you will have the opportunity to gain valuable hands-on learning with veterinary staff who are qualified trainers and assessors.
